The Senior Nutrition Program is open to individuals 60 years of age or older and their spouse for a small donation of \$2.50 per meal. The Center is open Tuesday through Friday from 9 a.m. to 2 p.m., with meals served at 12 p.m. (noon), and is located at 108 W. Kings Street. If you plan to come and enjoy one of the delicious meals, the one thing we ask is that you call before 11 a.m. the previous day to order a meal. Our phone number is 386- 5861.

Next week's menu is as follows:

Tuesday, Feb. 7 - Tuna noodle casserole, carrots with parsley, winter blend, fresh fruit, cookie, whole wheat bread and milk.

Wednesday, Feb 8 - tossed salad, arroz con pollo, fajita blend veggies, blushing pears, dinner roll and milk.

Thursday, Feb. 9 - Asparagus salad, beef jardiniere, baked yams, Italian blend, fruit parfait, whole wheat bread and milk.

Friday, Feb. 10 - Ravioli casserole, carrots with oregano, asparagus, strawberry applesauce, chocolate cake, dinner roll and milk.

Along with the meal program, seniors work jigsaw puzzles and visit

before lunch and enjoy Nickel Bingo for approximately one hour following lunch. Also, individuals who eat with the group at least once a week are eligible to go on various outings throughout the year.

The Avenal Recreation Department has a fitness room at the center which is available from 9 to 2 p.m. Tuesday through Friday for any senior citizen or community member to exercise. This is free of charge. The goal

of the Senior Center is to provide activities of interest for improving both mind and body. No

senior should be home alone when the Center provides one good meal a day, time to have fun and

a chance to visit with their peers.

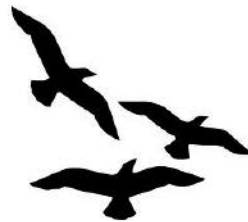
